# 2025 Federal Agenda

# QUALITY OF LIFE

- ★ The Chamber supports federal funding for projects, initiatives, programs and agencies that enhance the cultural arts and all aspects of the quality of life for residents of Decatur-Morgan County.
- \* The Chamber believes the Wheeler National Wildlife Refuge is a national and regional treasure in need of ongoing federal funding for improvements outlined in the One Decatur comprehensive plan, as well as additional support for adequate staffing.



## REGULATION

★ The Chamber opposes burdensome government regulations that impose costly, unfunded mandates and time-consuming restraints on businesses. We also oppose any legislation that prevents new and existing companies from competing in the global economy. We support results-driven programs that encourage U.S. location advantages, increased entrepreneurship and support of the free enterprise system to help grow our economy.

## TRANSPORTATION AND INFRASTRUCTURE

- ★ The Chamber supports reauthorization of the National Transportation Bill that provides adequate funding for transportation projects that improve safety and mobility, reduce travel times and enhance economic prosperity throughout the north Alabama region.
- \* The Chamber supports the creation of a federal highway building program for major regional transportation projects.
- ★ The Chamber believes investing in Alabama's infrastructure will protect its citizens, generate economic growth and improve quality of life. We support and encourage Congress to fully fund and facilitate this effort.
- ★ The Decatur-Morgan County Chamber of Commerce supports the inland port in Decatur, recognizing its economic impact. The project benefits industries tied to the Port of Mobile and attracts new businesses. The Chamber advocates for a design that balances efficiency and sustainability

for both industry and the community. The Chamber prioritizes safe hazardous chemical transport in Decatur-Morgan County and proper training and equipment for emergency responders.

- The Chamber continues to support the completion of several transportation projects that facilitate travel and commerce on our roadways, waterways and in the air. To this end, we ask Congress to support Decatur-Morgan County by preserving equity in highway funding back to the Alabama Department of Transportation. We believe decision-making about the building and improvement of our transportation infrastructure should be driven by need, including the promotion of safety and the facilitation of economic development. Major Decatur-Morgan County transportation and infrastructure priorities include:
  - To continue funding for improvements on U.S. Alt 72/U.S. Hwy 31/state Route Hwy 20 to create a limited access roadway from the I65/I565 interchange to U.S. Hwy 31/ Hwy 20/ Wilson Street intersection.
  - The funding for a third regional Tennessee River Bridge to connect Decatur-Morgan County to Huntsville and the Shoals.
  - Widening Hwy 31 south on the causeway from two lanes to three with a new three-lane bridge to provide continual free-flowing west bound traffic on Hwy 20.
  - Funding for the expansion of state Route Hwy 67 from two to four lanes from Priceville to the state Route Hwy 36 intersection.
  - Continued financial support and funding for the growth of the Pryor Field Regional Airport.
  - Continued financial support of Huntsville International Airport.
  - Improvements to the state Route Hwy 67/ Interstate-65 Interchange to improve traffic flow, safety and commute times.
  - The construction of a City of Hartselle bypass from Interstate 65 / Bethel Road (including a new interchange) to U.S. Highway 31.

- The Chamber supports federal funding for the new Chickamauga Lock, which is located on the Tennessee River near Chattanooga, Tennessee and continued annual funding until the project is completed.
- ★ The Chamber supports federal funding to repair the main gate and the inoperable floating boom wall at Wilson Dam Lock, located on the Tennessee River in Lauderdale County. Repairing, restoring and maintenance to the lock and dam is vital to our supply chains, ensures safety, expedites commerce and supports the local and U.S. economy, as well as national security.
- ★ The Chamber strongly opposes any inter-basin transfer of the Tennessee River.
- ★ The Chamber strongly supports the protection of the Tennessee River from any economic development project that produces hazardous materials, poses potential environmental threats or negatively affects the community's quality of life.
- The Chamber supports any federal, state, regional or private efforts designed to resolve issues and provide low cost, reliable rail service to our members.
- ★ The Chamber supports the addition of electric vehicle charging stations throughout Decatur-Morgan County.

## EDUCATION AND WORKFORCE DEVELOPMENT

- ★ The Chamber strongly supports the funding for marketing, economic recruitment efforts and expansion of all phases of the Alabama Robotics Technology Park.
- The Chamber strongly supports the continuance of funding for programs aimed at increasing the level of highly skilled, highly trained individuals.
   Specifically, the Chamber urges funding of Calhoun Community College's workforce development training programs and advanced workforce skils at four-year universities.
- ★ The Chamber strongly supports federal funding to increase the number of career coaches based on enrollment numbers to assist students with career preparation.

- ★ The Chamber supports federal funding for highquality early education opportunities (including head start, Pre-K, early education, professional development for personnel and more), with ample flexibility for local authority in implementation.
- ★ The Chamber supports the continued growth of the Alabama Center for the Arts including robust student recruitment, increased community engagement, dualenrollment and student housing. These initiatives, in addition to the Cook Museum of Natural Science, will advance efforts to establish a STEAM-based (Science, Technology, Engineering, Arts and Mathematics) economy in downtown Decatur.
- ★ The Chamber supports continued funding and expansion of workforce development initiatives including the Workforce Innovation and Opportunity Act (WIOA), Alabama Industrial Development Training (AIDT), Alabama Technology Network (ATN) and the ACCS Innovation Center to strengthen skills and opportunities across the region.
- ★ The Chamber supports the *Library Services and TechnologyAct* (LSTA). We believe funding for this act is vital to public libraries to continue to meet community needs, provide enhanced technology and reach underserved populations across the nation.
- The Chamber supports federal investment in higher education and workforce development through continued grant funding from organizations like the Alabama Community College System, U.S.
   Department of Education and Labor, the Appalachian Regional Commission, the Economic Development Administration, Small Business Administration, the National Science Foundation and ADECA (Alabama Department of Economic and Community Affairs).
   These resources are essential for building a highly skilled workforce, fostering innovation and driving long-term economic competitiveness for both our community and the nation.
- ★ The Chamber urges the federal government to consider increasing the Pell Grant eligibility threshold or establishing an additional scholarship program to support students who have exhausted Pell Grant funding. Expanded financial support is essential to help all students, especially those pursuing baccalaureate and advanced degrees, achieve their educational goals.

#### **IMMIGRATION REFORM**

★ The Chamber urges Congress to pass comprehensive immigration reform. Such reform should include strengthening the security of the United States borders and more stringent penalties against employers who employ illegal or undocumented workers.

#### HEALTHCARE

- ★ The Chamber supports legislation that would provide meaningful Medicare/Medicaid reform including:
  - Reach an equitable resolution on the Medicare wage index issue so that hospitals and other healthcare providers in the region will be fairly reimbursed for the services they provide to the Medicare population.
  - Establish initiatives that ensure businesses, particularly small and midsized businesses, are able to continue to provide affordable health coverage for their employees.
  - Bring about meaningful medical malpractice reform.
  - Continue enhancements to the Alternative Payment Models to ensure physicians are incentivized to create open practice models so that patients will have expanded access to preventive healthcare.
  - Address the redundant and ineffectual costs associated with the implementation of the Recovery Audit Program (RAC) and its application in the Medicare and Medicaid programs.
  - Allow for intrastate selling of insurance to increase competition and lower costs.
- ★ The Chamber supports legislation for and the recruitment of Federally Qualified Health Centers (FQHCs), which strive to help meet the needs of underserved areas and populations.



- ★ The Chamber supports legislation that provides funding/incentives to our nation's community mental health centers to ensure the centers cover a broad range of mental health services including: 24-hour crisis care, increased integration of physical, mental and substance abuse treatment and expanded support for families of people living with mental health issues.
- ★ The Chamber opposes legislative or regulatory changes to federal funding formulas, including the Federal Medical Assistance Percentage (FMAP), that would negatively affect the state-federal Medicaid program, healthcare providers in the Medicare program or Medicare reimbursement rates.

# **ENERGY POLICY**

- ★ The Chamber supports the further development of advanced electric power generation and transmission grid improvements that allow for sustainable growth while delivering low cost, reliable power for industrial, commercial and residential customers. Specifically, we support adding Small Modular Reactors (SMRs), Storage Integration and a Regional Grid Transformation (RGT) to protect our region from power disruption.
- ★ The Chamber supports TVA's efforts to increase its portfolio of TVA-owned generation in support of power supply reliability, resiliency and economic development activities.
- ★ The Chamber believes that the Tennessee Valley Authority (TVA) Act should be amended to require that TVA Board Members come from each state served by TVA in order to ensure that Alabama has adequate and consistent representation.
- ★ The Chamber strongly supports a U.S. energy policy that provides defined environmental standards and restores balance to U.S. energy markets by promoting a diverse, flexible energy supply at globally competitive prices. Furthermore, we support the removal of unintentional regulatory barriers to safe, clean, reliable energy, especially electricity supplied by co-generation technology.
- ★ The Chamber opposes any efforts to limit or eliminate tax-exempt municipal bonds given the adverse impact on our public power utility companies and their customers.

# TAX ISSUES

#### ★ The Chamber supports:

- Replacing the current tax code with a new system that is simple, stable and eliminates multiple-taxation and is tied to governmental accountability and responsible spending.
- Elimination of the Federal Unemployment Surtax and returning Federal Unemployment Tax Act (FUTA) revenues to the states.
- The permanent repeal of the estate tax.
- Adjustments to or the elimination of the alternative minimum tax.
- Lowering the corporate tax rate to increase worldwide opportunities for U.S. companies.

## HOMELAND SECURITY

- ★ The Chamber supports the National Drone Advanced Air Mobility Act which promotes domestic production and deployment of unmanned aircraft systems (drones) and advanced air mobility technology. It also bolsters research and development of University of Alabama Huntsville (UAH) and Alabama Agriculture and Mechanical University (AAMU) by providing funding and creating an initiative to coordinate research across federal agencies.
- ★ The Chamber supports the Protecting America's Agricultural Land from Foreign Harm Act of 2023 which prohibits the purchase or lease of U.S. agricultural land by individuals associated with the governments of China and other foreign adversaries.
- ★ The Chamber supports domestically produced steel instead of imported steel. Steel plays a significant role in national security and our economy. America's steel-related manufacturing has been moved offshore which creates a dangerous dependency upon foreign sources of steel supply and demand.
- ★ The Chamber will monitor the installation and impact the solar panel industry has on the local economy, land usage and will continue to support the Farmland Protection Policy Act which is intended to minimize the impact Federal programs have on the unnecessary and irreversible conversion of farmland to nonagricultural uses. Additionally, the Chamber advocates for the use of American-made products such as First Solar

panels and wind power technologies, to promote domestic manufacturing and energy innovation.

★ The Chamber supports predictable annual funding legislation that will avoid government shutdowns.

#### SPACE AND DEFENSE

- ★ The Chamber strongly supports NASA's ambitious and exciting new direction in space exploration and fully supports the nearby NASA Marshall Space Flight Center.
- ★ The Chamber supports legislation and funding that ensures Alabama's active military and space facilities, as well as its reserve and guard units, are maintained at a competitive level. This should include funding the Alabama National Guard's *Readiness Center Transformation Master Plan* (RCTMP).
- ★ The Chamber recognizes the valuable role military activities based in north Alabama play in the defense of our nation. The prospect of future rounds of Base Realignment and Closure however, make infrastructure improvements a continuing top priority for the community. We urge Congress to continue federal funding for infrastructure throughout north Alabama, particularly in the area of transportation improvements.
- The Chamber fully supports United Launch Alliance (ULA) and urges Congress to take certain requirements into consideration when ensuring a smooth transition into the next phase of the National Security Space Launch program. The Chamber urges Congress to:
  - Require U.S. launch providers to meet all critical mission requirements to protect from adversary threats and provide assured access to space.
  - Continue to purchase launches through block buys which stabilizes the industrials base and provides for the lowest possible prices.
  - Build upon the unprecedented success and flexibility established in the National Security Space Launch Phase 2 program and ensure that contracts for launches of national security payloads are awarded within the National Security Space Launch.
  - Maintain the highest standards for our nation's critical capabilities and ensure robust mission

assurance remains a top priority, while also advancing our space industrial base.

★ The Chamber urges congressional support for relocating the Space Command headquarters to Huntsville, Alabama.

# TRADE

- \* The Chamber urges Congress to strengthen enforcement mechanisms against unfair trade, including such practices as dumping, currency manipulation, closed markets and anti-competitive industrial policies. The Chamber recognizes a limited rationale for government intervention, based on legitimate national security concerns and unilateral efforts to level the trade playing field.
- ★ The Chamber advocates for congressional oversight and accountability in the evaluation of trade agreements such as the *North American Free Trade Agreement* (NAFTA).

## LABOR RELATIONS

- ★ The Chamber opposes any legislation that would enhance union organizing or bargaining rights over what is currently allowed by the *National Labor Relations Act* or other current legal or regulatory guidelines.
- The Chamber also opposes any legislation that would infringe upon private property rights by mandating that unions have access to an employer's property during union campaigns.
- ★ The Chamber supports legislation that prohibits the National Labor Relations Board from ordering any employer to close, relocate or transfer employment under any circumstance.
- ★ The Chamber supports legislation that would ensure the continuation of right-to-work statutes.
- ★ The Chamber supports legislation that would immediately modify the Davis-Bacon Act to create an equal opportunity for all workers and reduce inflated construction costs by billions annually.
- ★ The Chamber understands the need to update the salary level provided in the *Fair Labor Standards Act* (FLSA) for exempt employees. However, the Chamber does not support large increases because of the challenges it presents to small businesses, retail, restaurants and non-profits.

★ The Chamber opposes any proposed rule that makes it more difficult for employers to educate employees about unions and unionization prior to a vote.

#### ECONOMIC AND COMMUNITY DEVELOPMENT

- ★ The Chamber strongly supports the mission of the Decatur Downtown Redevelopment Authority (DDRA) to implement the Envision Decatur plan updated in the One Decatur plan and urges federal funding for its projects.
- ★ The Chamber urges the U.S. General Services Administration (GSA) to infill space vacated by the Federal Courts with new federal services and increase available parking at the U.S. Post Office building in Decatur.
- ★ The Chamber supports policies that promote enhanced access to affordable broadband for all our citizens and businesses; encourage new investment, jobs and technology development and deployment across our community; and promote increased competition and options for consumers and businesses. We support public policy that leads to the promotion of investment in deploying broadband facilities to the greatest extent and avoids unnecessary government intervention and regulation of the internet, which will inevitably drive-up costs for businesses and consumers.
- ★ The Chamber supports the extension of safe-harbor legislation to limit legal liability for those businesses, churches, hospitals and other organizations that have properly followed all employee, customer and visitor guidance and protocols.
- ★ The Chamber urges the Governor to seek federal approval for the transfer of unutilized opportunity zones to more promising eligible census tracts under the Tax Cuts and Jobs Act of 2017.

# TOURISM

- ★ In 2026, America will celebrate its 250th birthday and the public will be encouraged to connect with the nation's special places and experience its unique stories. The Chamber calls for making needed investments now in policies and programs to ensure that all communities are able to engage in the national celebration and the economic benefits of tourism are fully leveraged and shared.
- ★ Cultural resources are the sites, districts, structures, objects, practices and stories that detail our shared history. These resources provide individuals and communities with a sense of belonging, continuity and connection to their roots. From the Civil War to the Civil Rights Movement, cultural resources are an important part of Alabama's tourism landscape. The Chamber supports the Cultural Resources Challenge Act, which would provide \$250 million over 5 years to help the National Park Service to protect, restore and archive our country's diverse history.
- National Scenic Byways recognize and protect historic, scenic and culturally significant roads. The designation brings substantial recognition and economic benefits to nearby communities, especially rural communities, by attracting visitors who spend money on local businesses and services. Alabama has four National Scenic Byways: Alabama's Coastal Connection, the Natchez Trace Parkway, Selma to Montgomery Historic Trail and the Talladega Scenic Drive. The Chamber calls for maintaining the program with an appropriation of at least \$25 million.
- The Chamber supports the "Singing River Trail" which will be a 200-plus-mile greenway system. It will strengthen regional bonds and create new health and wellness, educational, economic, tourism and entrepreneurial opportunities for the people and communities throughout north Alabama.

- To study and recommend improvements along U.S. Alt 72/Hwy 20 from the Wilson Street intersection to the Morgan/Lawrence County line.
- Widening U.S. Hwy 31 south on the causeway from two lanes to three with a new three-lane bridge to provide continual free-flowing west bound traffic on Hwy 20.
- The construction of a third regional Tennessee River Bridge to connect Decatur-Morgan County to Huntsville and the Shoals.
- The expansion of state Route Hwy 67 from two to four lanes from Priceville to the state Route Hwy 36 intersection.
- Improvements to the state Route Hwy 67/ Interstate 65 interchange to improve traffic flow, safety and commute times.
- The construction of a City of Hartselle bypass from Interstate 65 / Bethel Road (including a new interchange) to U.S. Hwy 31.
- Enhancing all modes of freight movement in the region to allow for maximum safety and efficiency.
- \* The Chamber believes investing in the state's infrastructure will protect Alabama's citizens, generate economic growth and improve quality of life. We support and encourage the legislature to fully fund and facilitate this effort.
- ★ The Chamber supports improvements at the Interstate 65/state Route 36 Interchange in the City of Hartselle to improve traffic congestion, safety and travel times.
- ★ The Chamber also encourages the construction of other safe, low-cost projects that could be completed to enhance bicycle and pedestrian usage in the downtown areas and around schools throughout the north Alabama region. These

projects should connect to current trails in the Decatur, Hartselle, Priceville, Trinity areas and Wheeler Wildlife Refuge. This includes funding to continue construction, maintenance and rehabilitation as well as adding greenways to the Dr. Bill Sims Bicycle Trail that provides transportation alternatives and recreational opportunities throughout Decatur-Morgan County. The Chamber supports the "Singing River Trail" that will connect counties throughout north Alabama.

- ★ The Chamber encourages the pursuit of quality-oflife funding specifically through the Transportation Alternatives Program (TAP), carbon reduction refunds, which provides funding for on- and offroad pedestrian and bicycle facilities, including sidewalks, pedestrian lighting, downtown streetscape, historic preservation and rehabilitation of historic transportation facilities and other transportation projects to achieve compliance with the Americans with Disabilities Act of 1990.
- ★ The Chamber supports state funding for the growth of the Pryor Field Airport Authority, Huntsville International Airport and for the continued funding of the 'Alabama Airport Economic and Infrastructure Program' at a minimum of \$25 million to ensure Alabama airports can meet infrastructure demands.
- ★ The Chamber opposes any inter-basin transfer of the Tennessee River and we urge the Alabama Legislature to pass statewide water-usage legislation. Navigation should be a key component of such a plan.
- ★ The Decatur-Morgan County Chamber of Commerce supports the inland port in Decatur, recognizing its economic impact. The project benefits industries tied to the Port of Mobile and attracts new businesses. The Chamber advocates for design that balances efficiency and sustainability for both industry and the community. The Chamber prioritizes safe hazardous chemical transport in Decatur-Morgan County and proper training and equipment for emergency responders.
- ★ The Chamber supports the addition of electric vehicle charging stations throughout Decatur-Morgan County.
- ★ The Chamber encourages the Governor and the Alabama Department of Transportation to widen
   I-65 to a minimum of six lanes throughout the state.

# ECONOMIC AND COMMUNITY Development

- ★ The Chamber strongly supports the mission of the Decatur Downtown Redevelopment Authority (DDRA) to continue to implement the Envision Decatur plan updated in the regionally recognized One Decatur plan and urges state funding for its efforts.
- ★ The Chamber strongly supports the mission of the Alabama Office of Apprenticeship and increased incentives for companies to train youth apprentices and work-based learning in high school. We also support the Alabama Community College System's effort to expand quick-start preapprenticeship programs that lead to nationally recognized certifications that prepare residents for in-depth apprenticeships or entry-level jobs in manufacturing and short-term programs that place residents in one of several high-wage, in-demand occupations. We also encourage incorporating industry recognized credentials into these programs.
- ★ The Chamber strongly supports policies and funding to encourage small business development, entrepreneurship and business lending programs throughout Alabama.
- ★ The Chamber supports continued funding for the Alabama Technology Network (ATN) and the Alabama Industrial Development Training (AIDT) initiative, which serve as catalysts for economic growth by supporting business and industry throughout the State of Alabama.
- The Wheeler National Wildlife Refuge is a national and regional treasure that has lacked the proper funding for necessary updates for optimum access and use by the community. The Chamber urges the state to approve any appropriate funds for a master plan as outlined in the One Decatur comprehensive plan.
- ★ The Chamber encourages regional collaboration among economic development agencies.
- ★ The Chamber strongly supports the state's comprehensive economic development plan, Catalyst and the mission of the state to diversify its economic development efforts and steer Alabama towards technology-focused, skills-based jobs that result in lasting opportunities for Alabama citizens.

- ★ The Chamber supports the renewal and continuous improvements to Alabama's statutory and discretionary incentive programs to assist in recruiting, retaining and sustaining new and existing businesses.
- ★ The Chamber supports the development of publicprivate partnerships especially in cases where public funds are not available for worthwhile projects.
- ★ The Chamber supports the privatization of the state-run ABC stores.
- ★ The Chamber calls on our state legislature to intercede on behalf of business and economic growth to create a streamlined process for permitting access to state highways.
- ★ The Chamber believes state building codes should be adopted and enforced uniformly across the state. Failure to do so hurts those municipalities that are following the rules.
- ★ The Chamber believes state agencies should verify that all zoning and local restrictions are satisfied before any group homes are certified and funded by the State of Alabama.
- ★ The Chamber supports policies that promote enhanced access to affordable broadband for all our citizens and businesses; encourage new investment, jobs and technology development and deployment across our community; and promote increased competition and options for consumers and businesses. We support public policy that leads to the promotion of investment in deploying broadband facilities to the greatest extent and avoids unnecessary government intervention and regulation of the internet, which will inevitably drive up costs for businesses and consumers.
- ★ The Chamber urges the Governor to seek federal approval for the transfer of unutilized opportunity zones to more promising eligible census tracts under the Tax Cuts and Jobs Act of 2017.
- ★ The Chamber supports the extension of safe-harbor legislation to limit legal liability for those businesses, churches, hospitals and other organizations that have properly followed all employee, customer and visitor guidance and protocols.
- ★ The Chamber supports TVA's efforts to increase its portfolio of TVA-owned generation in support of power supply reliability, resiliency and economic development activities.

- The Chamber supports the proposed City Harbor project and believes necessary improvements, including addressing residential deed restrictions based on elevations for condominiums and any other impediments that need to be coordinated with TVA, should be prioritized by our elected officials to ensure this economic development project moves forward expeditiously.
- ★ The Chamber fully supports the efforts of the Morgan County Economic Development Association (MCEDA) in locating, evaluating and developing new industrial sites for continued investment and job creation in Morgan County. The Chamber also supports MCEDA applying for site evaluation and development grants utilizing the state of Alabama's new Site Evaluation and Economic Development Strategy Act (SEEDS) program that will allow the State Industrial Development Authority to invest in and accelerate the development of industry-ready sites at a time when available sites are scarce.

# **EDUCATION**

- ★ The Chamber urges the continuation of the highest standards possible to ensure student success and growth.
- ★ The Chamber advocates for improved state test scores for students in both math and reading and supports whatever investment is required to this end, including strong support of the Literacy Act and the Numeracy Act.
- \* The Chamber supports increasing the number of National Board Certified Academic Language Therapists (CALT), National Board Certified teachers and STEM (Science, Technology, Engineering and Math) Certified educators in our state.
- ★ The Chamber encourages post-secondary training for teachers in the science of learning in math, science, computer science literacy and English as a second language (ESL).
- ★ The Chamber urges the Alabama Legislature to continue to make funding for statewide Pre-Kindergarten and a plan for sustainable, quality early education in childcare programs and facilities a priority in the 2025 regular legislative session.
- ★ The Chamber calls upon the Governor and the Legislature of the State of Alabama to take immediate action to reform education spending to studentcentered funding in ways necessary to maximize

public trust and to secure sufficient additional revenues for high quality education from Pre-Kindergarten through post-secondary education.

- ★ The Chamber supports a graduation rate formula that is based on the number of students who complete the high school program, allows special education students who complete their Individual Education Plan (IEP) to be counted as graduates, recognizes General Education Diploma (GED) as a diploma option and does not penalize schools for creating "drop-back-in" options.
- ★ The Chamber supports increasing the weight on the school A-F Report Card for the College and Career-Ready Indicator over the Graduation Rate Indicator.
- ★ The Chamber strongly supports funding to increase the number of career coaches based on enrollment numbers to assist students with career preparation.
- ★ The Chamber encourages public high schools and institutions of higher education to implement personal financial management programs and accountability measures.
- ★ The Chamber believes that while a strong technical education is important for setting students on a path to high demand STEM fields, it is also important that public high schools and institutions of higher education promote greater understanding of 21st century skills that are transferable across all industry sectors. Employers increasingly voice the need for employees that are able to think critically, collaborate and communicate effectively. Essential skills such as professionalism, interview skills, social media acumen and email etiquette are becoming increasingly important and should become a regular part of our curriculum.
- ★ The Chamber supports the promotion of positive instructional methods and the responsible use of Artificial Intelligence (AI) within a secure, closed platform that fosters meaningful connections between students, teachers, counselors and parents.
- ★ The Chamber encourages continued funding for technology, robotics and distance learning in all Alabama school systems.
- ★ The Chamber supports continuing to increase funding for dual enrollment.
- ★ The Chamber supports the restructuring and increasing the allocation of state funds to effectively meet the needs of ESL programs, special education services and behavorial support initiatives based upon student enrollment in these programs.

- ★ The Chamber supports continued expansion of Calhoun Community College, Athens State University and the growth of higher education institutions.
- ★ The Chamber supports the continued growth of the Alabama Center for the Arts, including robust student recruitment, increased community engagement, dual enrollment and student housing. These initiatives, in addition to the Cook Museum of Natural Science, will advance efforts to establish a STEAM-based (Science, Technology, Engineering, Arts and Mathematics) economy in downtown Decatur.
- ★ The Chamber fully supports the funding of Alabama's two-year college system based on regional needs.
- ★ The Chamber strongly supports the Business Education Alliance (BEA). This alliance was created through the Business Council of Alabama (BCA) to assist in providing the best education opportunities and skills training available for Alabama's publicschool students.
- ★ The Chamber supports the Craft Academy in Morgan County for teaching construction trades to high school students.
- ★ The Chamber supports the training and employment of AIDB (Alabama Institute for Deaf and Blind) students at the campus in Decatur.
- ★ The Chamber supports reforming teacher certification requirements to allow experienced professionals with a bachelor's degree in career and technical fields to qualify to teach relevant subjects without additional coursework. Simplifying certification would help address teacher shortages by enabling skilled professionals to share their expertise directly with students.
- ★ The Chamber advocates for increasing the earning potential for retired teachers from \$37,000 to \$52,000 annually while they continue to receive retirement (RSA) benefits, aligning Alabama with similar provisions in surrounding states. This initiative aims to address staffing shortages by attracting experienced educators back into the workforce.

# WORKFORCE DEVELOPMENT

★ The Chamber strongly supports the funding for marketing and economic recruitment efforts of all phases of the Alabama Robotics Technology Park and encourages cooperation with area schools, colleges, unversities and businesses to develop appropriate curriculum and degrees.

- ★ The Chamber recognizes and supports the need for life-long learning and continuous education and skills development, particularly for individuals who are pursuing new career paths in the changing job market.
- ★ The Chamber supports the continuance and complete support of the *Workforce Innovation and Opportunity Act* (WIOA) through true partnerships in all areas of Region 1 and the new workforce agencies, to further support the Catalyst plan.
- ★ The Chamber strongly supports the continuance of funding for programs aimed at increasing the level of highly skilled, highly trained workers.
   Specifically, the Chamber urges funding of Calhoun Community College's workforce development training programs.
- ★ The Chamber recognizes and supports the critical need for advanced workforce development in colleges and universities to equip students with skills necessary to meet the evolving demands of industries and ensure long-term economic growth and competitiveness.
- ★ The Chamber encourages the development of quality corporate childcare models to provide and create services through private/public partnerships and state support. Providing attainable childcare for Alabama's workforce continues to be essential for workforce retention and growth.
- ★ The Chamber recognizes the importance of baccalaureate and advanced graduate degrees for the preparation of the workforce and supports the ongoing development of baccalaureate and postbaccalaureate degree programs in relevant and high-demand occupations.
- ★ The Chamber acknowledges the important role of partnerships between higher education institutions and industry that create internships, apprenticeships, work-based learning and other types of experiential learning opportunities that benefit current and future advanced workforce needs.
- ★ The Chamber supports continued grant funding for workforce development and education improvement programs through the Department of Education, the Alabama Community College System, the Alabama Workforce Council and the Economic Development Administration.
- ★ The Chamber supports the continued funding and expansion of the ACCS Innovation Center, a division of the Alabama Community College System.

# HEALTHCARE

# QUALITY OF LIFE

- ★ The Chamber supports funding for projects, initiatives, programs and agencies that enhance the cultural arts and all aspects of the quality of life for residents of Decatur and Morgan County.
- ★ The Chamber supports funding for public libraries as vital community places that fulfill the informational, educational, cultural and recreational interests for residents of Decatur and Morgan County.

# ECONOMIC DEVELOPMENT

- ★ The Chamber strongly endorses the One Decatur comprehensive plan and its full funding and implementation by all responsible parties on the time schedule outlined in the plan.
- \* The Chamber encourages the city of Decatur to implement a comprehensive growth strategy to include the continued implementation of the One Decatur comprehensive plan and work to consider all options available to the city conducive for strategic



growth. We also support the implementation and reviewing of building design standards of the second phase of the long-range plan which includes the implementation of the new zoning ordinances.

- ★ The Chamber highly recommends the city of Decatur allocate a minimum of one percent of the budget each fiscal year to spur development. Additional monetary and in-kind incentives are also urged to be considered by the city of Decatur and the Morgan County Commission when appropriate.

## Industrial Tax Abatements / Retail Development Incentives

★ The Chamber assesses the need for industrial tax abatements and retail development and residential incentives on a case-by-case basis; however, we support the use of tax abatements and incentives when accompanied by a measurable plan for new capital investment, job creation, job preservation, revenue generation, revitalization and economic development in all municipalities of Morgan County. We encourage companies and developers receiving tax abatements and incentives to continue reinvestment in the local community by utilizing Decatur and Morgan County based vendors and suppliers in addition to our talented workforce and strongly promote living in Decatur-Morgan County.

- ★ The Chamber encourages the development/ expansion of fiber networking for residential and commercial entities.

# Business Taxes, Fees and Licenses

★ The Chamber urges city and county departments to continually analyze and streamline business guidelines in order to create a more efficient and business-friendly atmosphere. Furthermore, the city of Decatur and the Morgan County Commission should conduct a comparative analysis of business licenses, taxes and fees in surrounding cities to ensure that fees in our area are comparable and do not impede economic growth within the city and county.

#### Tourism

- ★ The Chamber recognizes tourism as an important revenue-producing industry in Decatur and Morgan County and urges support from the Decatur City Council and Morgan County Commission for tourism product promotion and development.
- ★ The Chamber supports the continued development of parks and sporting venues that are consistent with the quality standards established that will bring new events and tournament opportunities to the city and county that increase lodging tax collections.
- ★ The Chamber affirms that projects which promote and recognize the artistic, cultural and historical resources of the city and county are necessary to the growth of a well-rounded community. The creation of facilities, trails, exhibitions and special events that celebrate area heritage and culture will be encouraged as an important aspect of tourism development.
- ★ The Chamber supports the "Singing River Trail" which will be a 200-plus-mile greenway system. It will strengthen regional bonds and create new health and wellness, educational, economic, tourism and entrepreneurial opportunities for the people and communities throughout north Alabama.
- ★ The Chamber supports the Dr. Bill Sims Bike Trail Project, which expands the trail by 8.77 miles into the Old Town District, connecting it to essential destinations within the city and regionally to the Singing River Trail.
- ★ The Chamber supports Decatur Morgan County Tourism's enrollment as a Tennessee RiverTown Community.
- ★ The Chamber supports the Point Mallard Vision Committee and their efforts to explore expansion of Point Mallard Park.

- ★ The Chamber supports funding a master plan for Wheeler National Wildlife Refuge.
- ★ The Chamber supports the mission of and continued municipal and county funding for Decatur Morgan County Tourism.
- ★ The Chamber endorses all initiatives aimed at establishing and funding a Civil Rights District within Decatur-Morgan County. This district would encompass the Decatur Scottsboro Boys Civil Rights Museum and the Judge J. Horton Legal Learning Center located in Old Town, offering invaluable educational opportunities and training, all with the objective of integrating it into the Alabama Civil Rights Trail.

# Morgan County Economic

#### Development Association

- \* The Chamber supports the mission of and continued municipal and county funding for the Morgan County Economic Development Association (MCEDA).
- ★ The Chamber supports continued collaboration with neighboring county economic development organizations to develop new industrial sites and continued recruitment of new investment and job creation in adjacent and annexed areas of those counties.

## Decatur-Morgan County Entrepreneurial Center

★ The Chamber supports the mission of and encourages municipal and county support for the Decatur-Morgan County Entrepreneurial Center.

# **ILLEGAL IMMIGRATION**

★ The Chamber urges local officials to comply with and enforce existing laws addressing illegal immigration in as efficient a manner as possible.

# EDUCATION AND WORKFORCE Development

# Advanced Technology Robotics Research and Development Complex

★ The Chamber strongly supports the funding for marketing and economic recruitment efforts of all phases of the Robotics Technology Park and encourages cooperation with area schools, colleges, universities and businesses to develop appropriate curriculum and degrees.

#### Funding and Administration

- The Chamber enthusiastically supports the priority placed on public education and encourages continued municipal and county funding for school systems in Decatur-Morgan County.
- ★ The Chamber supports a long-range growth plan of Decatur City School System facilities as more rooftops are being built in the city.
- The Chamber urges all school systems in Morgan County to continue reinvestment in the local community by utilizing Decatur and Morgan County based vendors and suppliers.
- ★ The Chamber encourages the school systems of Decatur-Morgan County to proactively promote their successes in all types of media.
- ★ The Chamber encourages and enthusiastically supports the ongoing efforts of the school systems of Decatur-Morgan County to improve student achievement including test scores and graduation rates.
- ★ The Chamber recognizes the importance of baccalaureate and advanced graduate degrees for the preparation of the workforce and supports the ongoing development of baccalaureate and post-baccalaureate degree programs in relevant and high-demand occupations.
- The Chamber acknowledges the important role of partnerships between higher education institutions and industry that create internships, apprenticeships, workbased learning and other types of experiential learning opportunities that benefit current and future advanced workforce needs.

#### **Career Preparation**

★ The Chamber strongly supports the mission of the Alabama Office of Apprenticeship and increased incentives for companies to train youth apprentices in high school. We also support the Alabama Community College System's effort to expand quick-start preapprenticeship programs that lead to nationally recognized certifications that prepare residents for in-depth apprenticeships or entry-level jobs and short-term apprenticeship programs that place residents in one of several high-wage, indemand occupations.

- ★ The Chamber supports K-12 and higher education funding for the development of partnerships between Calhoun Community College, other higher education institutions and business and industry, focused on creating pathways for individual attainment of postsecondary education and skillsets, to achieve completion rates above the national average.
- ★ The Chamber strongly supports the expansion of career and trade education opportunities within all school systems in Morgan County along with strong partnerships with businesses and industries in our area. We also urge all school systems to collaborate and expand opportunities with Calhoun Community College's dual-enrollment program and utilize other early college credit opportunities for high school students.
- ★ The Chamber believes that while a strong technical education is important for setting students on a path to high demand STEM fields, the Chamber also encourages public high schools and institutions of higher education to promote greater understanding of 21st century skills that are transferable across all industry sectors. Employers increasingly voice the need for employees that are able to think critically, collaborate and communicate effectively. Essential skills such as professionalism, interview skills, social media acumen and email etiquette are becoming increasingly important and should become a regular part of our curriculum.
- ★ The Chamber recognizes and supports the critical need for advanced workforce development in colleges and universities to equip students with skills necessary to meet the evolving demands of industries and ensure long-term economic growth and competitiveness.
- ★ The Chamber recognizes and supports the need for life-long learning and continuous education and skill development, particularly for individuals who are pursuing new career paths in the changing job market.
- ★ The Chamber strongly supports funding to increase the number of career coaches based on enrollment numbers to assist students with career preparation.

- ★ The Chamber encourages public high schools and institutions of higher education to implement personal financial management programs and accountability measures.
- ★ The Chamber wholeheartedly supports the Best and Brightest Initiative (incentive package for STEM, education and nursing graduates) and the Decatur-Morgan CEO Program (Creating Entrepreneurial Opportunities for high school students).
- ★ The Chamber supports the Craft Academy in Morgan County for teaching construction trades to high school students.
- ★ The Chamber supports the training and employment of AIDB (Alabama Institute for Deaf and Blind) students at the campus in Decatur.

# TRANSPORTATION AND INFRASTRUCTURE

- ★ The Decatur-Morgan County Chamber of Commerce continues to support the completion of several projects that benefit travel and commerce including:
  - To continue funding for improvements on U.S. Alt 72/U.S. Hwy 31/state Route Hwy 20 to create a limited access roadway from the I65/ I565 interchange to Hwy 31/Hwy 20/Wilson Street intersection.
  - To study and recommend improvements along U.S. Alt 72/Hwy 20 from the Wilson Street intersection to the Morgan County/Lawrence County line.
  - The expansion of Hwy 67 from two to four lanes from Priceville to the state Route Hwy 36 intersection.
  - The construction of a third regional Tennessee River Bridge to connect Decatur-Morgan County to Huntsville and the Shoals.
  - Improvements to the state Route Hwy 67/ Interstate 65 Interchange to improve traffic flow, safety and commute times.
  - The construction of a City of Hartselle bypass from Interstate 65/ Bethel Road (including a new interchange) to U.S. Highway 31.
  - Enhancing all modes of freight movement in the region to allow for maximum safety and efficiency.

- Widening Hwy 31 south on the causeway from two lanes to three with a new three-lane bridge to provide continual free-flowing west bound traffic on Hwy 20.
- ★ The Chamber urges the city of Decatur to allocate resources to construct new roads and sewer improvements and improve existing roads to support current and planned infrastructure needs within the city of Decatur.
- ★ The Chamber supports improvements at the Interstate 65 / state Route 36 Interchange in the City of Hartselle to improve traffic congestion, safety and travel times.
- ★ The Decatur-Morgan County Chamber of Commerce supports the inland port in Decatur, recognizing its economic impact. The project benefits industries tied to the Port of Mobile and attracts new businesses. The Chamber advocates for a design that balances efficiency and sustainability for both industry and the community. The Chamber prioritizes safe hazardous chemical transport in Decatur-Morgan County and proper training and equipment for emergency responders
- ★ The Chamber supports the addition of electric vehicle charging stations throughout Decatur-Morgan County.

#### Local Funding Sources

- ★ The Chamber strongly encourages the Morgan County Commission and municipalities within Morgan County to establish reserve accounts for transportation projects. Such accounts would serve as revenue sources to fund local transportation improvement projects, including resurfacing, as well as serve as the local match for federal and/ or state transportation projects. The Chamber also encourages that the allocation of funds for these accounts be made annual budget priorities.
- ★ The Chamber encourages the continued financial support of public transportation by local governments including the study of expanded services within the Decatur metropolitan area.

## Bicycle and Pedestrian Trails

- ★ The Chamber urges the city of Decatur to continue construction, maintenance and rehabilitation of the Dr. Bill Sims Bicycle Path that provides transportation alternatives and recreational opportunities throughout the city of Decatur.
- ★ The Chamber also encourages the construction of other safe, convenient, low-cost projects that can be completed to enhance bicycle and pedestrian usage in the downtown areas as well as connecting residential areas with commercial centers, parks, schools and other public and private services. These projects should connect to current trails in the Decatur, Hartselle, Priceville and Trinity areas.
- ★ The Chamber encourages the pursuit of quality-oflife funding specifically through the Transportation Alternatives Program (TAP) which provides funding for on- and off-road pedestrian and bicycle facilities, including sidewalks, pedestrian lighting, downtown streetscape, historic preservation and rehabilitation of historic transportation facilities and other transportation projects to achieve compliance with the Americans with Disabilities Act of 1990. This must be a high priority and requires a great amount of vigilance as yearly application is required.
